



## 2011 Windward Capital Summer Enrichment Scholarship Application

Review Process:

Priority will be given to applications that demonstrate:

- a student's accomplishments both in school and in the community (reflected in letters of reference and the student's personal statement);
- the quality and academic rigor of the program;
- the need for financial assistance
