Qualifications:

To qualify for a 2013 Interlochen Center for the Arts Summer Camp Scholarship, a student must:

- Attend a public or private school on St. Croix, St. Thomas, or St. John;
- Provide documentation of acceptance into the 2013 Interlochen Center for the Arts Summer Camp program;
- Demonstrate financial need.

Proof of Financial Need:

Part II of the application includes a financial statement, which shows income, expenses, debts, and other financial data. To evaluate a student's financial eligibility for scholarship aid, parents/guardians must complete this statement. **FINANCIAL INFORMATION WILL BE STRICTLY CONFIDENTIAL.**

Review Process:

Scholarships will be funded through the Prior Family Foundation at the level of up to \$2,500 per student. Priority will be given to applications that demonstrate:

- A student's accomplishments both in the arts and in the community (reflected in letters of reference and the student's personal statement);
- Need for financial assistance.

- ___ a short personal statement (300 words or less).
